Re: Withdrawal of October 13, 2021 Revocation and Immediate Suspension of
Permit No. C-2017-012

Dear Ms. Ross and Ms. Meredith:

This letter shall serve as the City of Palm Springs' ("City") withdrawal of the Revocation and Immediate Suspension Letter for Permit No. C-2017-012 dated October 13, 2021 ("Revocation Letter"). The decision to withdraw the Revocation Letter was based on the issues raised by Ms. Ross during a December 2, 2021 teleconference call. While the City does not agree with Ms. Ross that the Revocation Letter did not provide Joy Industries, Inc. notice of all of the violations occurring at 370 W. San Rafael, Palm Springs, California 92262,¹ in order to avoid any of the issues raised by Ms. Ross the City is withdrawing the Revocation Letter. Thus, the hearing on December 9, 2021 will not proceed.

Please be advised that the City reserves any and all enforcement rights for violations of the City's Cannabis rules and regulations found in the Palm Springs Municipal Code and pertinent State laws and regulations.

¹ Revocation letter specifically notes that no cultivation is permitted at Unit # 6 and references video footage showing the clandestine removal of cannabis plants at 370 W. San Rafael based on the footage provided by Joy Industries, Inc.
